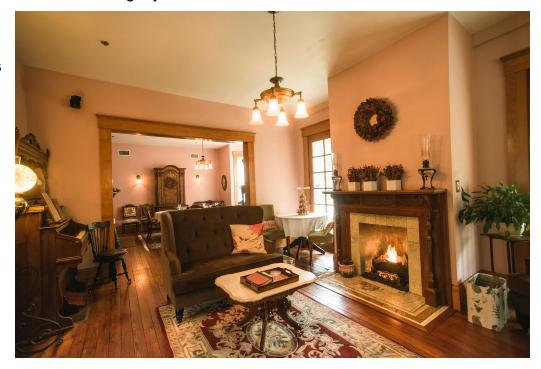
The Laurel Oak Inn

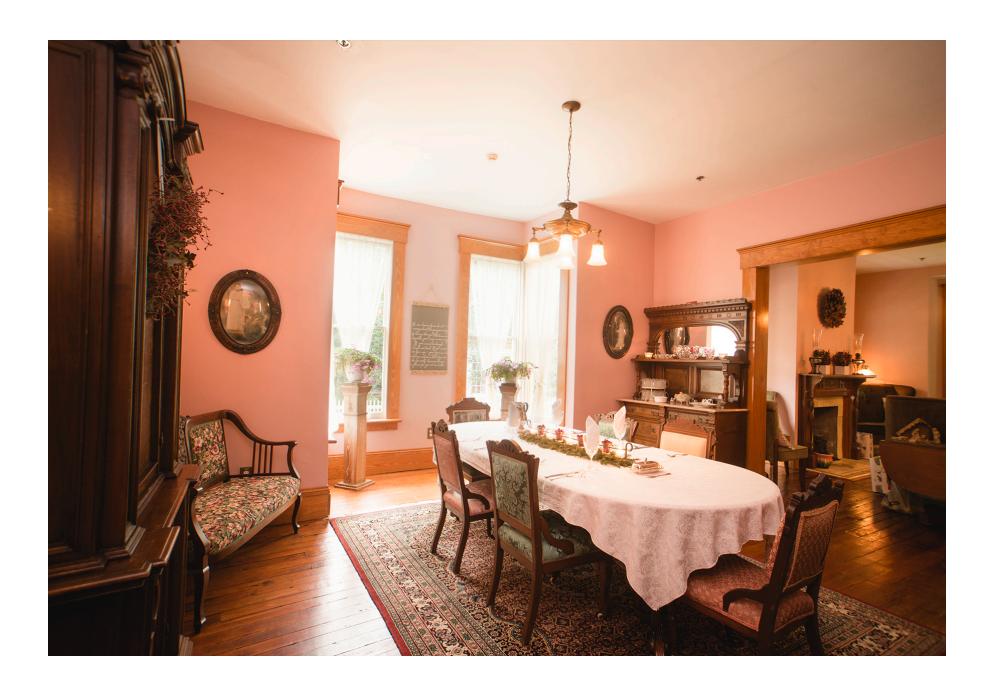
