#### **CHAS Economy Measures**

As everyone who follows the local and national news is aware, our state and nation are going through hard economic times.

CHAS is not immune. Our membership has declined slightly over the past two years and our operating expenses have increased; especially the horse care expenses. This trend has been accompanies by a reduction in the number or paying events and less money per event as event sponsor's budgets tighten.

While there is no immediate financial crisis threatening, the CHAS Board has begun investigating alternatives to reduce expenses and/or increase revenue. These actions are undertaken periodically by every prudent organization and are especially appropriate in these troubled economic times.

Some of the alternatives under review involve the sale of some of our unused equipment and potentially the adoption of some of our horse herd. Others include repairing and reconditioning equipment ourselves rather than paying others to do it. The Board will inform the membership as measures are identified so that there is no confusion as to what is happening.

Other ideas will be investigated as warranted. Contact your Member at Large if you have a revenue generating or cost cutting idea.

Last year at the Sacramento Jazz festival, Mike Johnson met a mounted police officer who's horse entertained the crowd by "dancing" to the music. That June the officer, LuAnne Holmsen, was seriously injured during a training session in San Francisco when her horse fell on her. The last news was that she was listed in stable condition. There was no more news about her... until a few weeks ago when Melinda Faubel was on an endurance ride.

"I was riding next to a women during last weekend's 65 at 20 Muleteam, held in Ridgecrest. We got to talking (there's a lot of talking that takes place on a 65 mile ride) and it turns out that this was her first ride back since being seriously hurt by a horse. She was from the Auburn area and mentioned that she was hurt on the job, as she was a police officer..... all of a sudden the pieces of the puzzle clicked and

I asked her if she was the officer whose horse "danced"! What a small world! I asked her if she would mind me forwarding an update to CHAS as we had heard about her accident and many of us would like to know that she was doing OK.

She wanted me to add a few details to the article that was published in the paper.

- 1. She wants everyone to know that it was NOT the dancing horse that flipped over on her. It was a mount that had some issues that she was schooling (but had never reared before). She doesn't remember anything past the horse rearing. She had extensive injuries (I won't go into them here but they were INCREDIBLE! I can't believe she's on a horse....) and was in a coma a week. During that time she also had a stroke.
- 2. She will probably be medically retired after an evaluation by a doctor, but is hoping that the dancing horse, who will also be retired in a few years, will be able to go to her after he is retired. She was the one the picked him out and did all his police training, and so feels a real connection.

## Call to Arms! - Roaring Camp

This coming Memorial Day weekend, May 23rd-25th, the ACWA will host the annual Roaring Camp Civil War Battles & Encampment in the Santa Cruz redwoods. This event is spread out over three days of "livin' history up!" The event site, Roaring Camp, was started by Isaac Graham in the 1830's and the saw mill opened in 1842, although the local forest was spared thanks to his wife who did not want the trees to be logged. Some time later, Mr. Graham started a tourist business hauling people up and down the mountain in the narrow-gauge railroad he built for the mill that never opened. Today, Roaring Camp is a year-round tourist destination, with numerous events from Easter to Christmas. But the Civil War event surpasses even Thomas the Tank Engine!



We'll have one gun. As for food; if you want to eat, bring some.... we might try a potluck on Saturday, like Tres Pinos. This event is great for skirmishing, so bring your side arms and rifles! I've heard that, so far, we're camped on the hill. In past years, arrival on Friday, the 22nd, is allowed past 2:00-2:30ish, after the school days are over. During the event, train battles go on throughout the day. The event has a dance on Sunday night, after the FREE re-enactor train ride up the hill and back. There is only one battle on Monday, after the Memorial Day ceremonies and Monday stay over is allowed. ## Cock & Pullet / Maverick's Returns to Mariposa





### LAS MARIPOSAS CIVIL WAR DAYS

#### The Civil War West of the Mississippi?

Perhaps not in the 1800's, but <u>MOST DEFINITELY</u> every spring on the last weekend in April, in beautiful Mariposa, CA, only 40 minutes outside of Yosemite National Park!



Taking its name from the historical landmark of John C. Fremont's 44000 plus acre Las Mariposas Land Grant, the Las Mariposas Civil War Days event draws importance from this as well as Fremont's settling in the town of Mariposa, CA, where many of the streets and buildings bear his family's name. The grant, purchased shortly after the Civil War, ran through the Sierra's mountains and fully encompassed Longs' Mariposa Ranch, site of the event.

Each year, the <u>Las Mariposas Civil War Days</u> reenactment takes place on over 50 acres of Longs' 3500 acre Williamson Act ranch. With its rolling hills, tree studded with every variety of Oak trees imaginable, this location has been flatteringly hailed by past participants as the best west coast site most resembling any actual historical battlefield.

#### What makes for a great Civil War Reenactment?

Let's start with the first commandment of a superior Civil War event: LOCATION. The Longs' Mariposa Ranch, with its open expanses for the cavalry, gullies and tree lines for foot soldiers, and majestic hilltops for cannon placement, provides the ultimate resemblance to actual historical battlefields of anywhere in the western United States. This is what makes the Las Mariposas Civil War Days site truly inspiring. By not being physically bound by any city or town restraints, the Las Mariposas Civil War Days is a reenactors' dream come true, and a more inviting venue on the west coast cannot be found.







Most importantly, this site promotes the freedom of its reenactors to fulfill their "living historical ambitions" any way they see fit. You can feel the "living history" aura all around. Each year, as the event grows, the LMCWG will continue to add to the site in order to improve the reenactors' experience. All of this, with an abundance of the standard accoutrements, makes it easy to see how this event is destined for success and perpetuity. With groups from all over the Western United States in attendance, this event is blossoming into the premier reenactment of its kind out west!

The next commandment of a superior Civil War Reenactment: SINCERITY. The Las Mariposas Civil War Group (LMCWG) whom presents the event is truly dedicated to educating the public about this critical era in our nations' history. More specifically, is the groups' desire in providing the attending reenactors the opportunity to bring to life their "living historic perspective". The LMCWG believes that these two go hand in hand: When the reenactor experience is successful, then BOTH parties have a mutually better experience.



Further proof of the LMCWG's desire to promote and preserve the general historical cognizance of this era is the group's unanimous decision to donate a portion of the proceeds of the event to the <u>Conservation Fund's Civil War Battlefield Campaign</u>. The group's goal is that as the event grows, so does their ability to further help in preserving those sites with historical significance.



More Than 25,000 Acres Saved

Additionally, the group is committed to sponsoring an annual academic Scholarship Fund in the hope of promoting our nation's history from an educational viewpoint.

The last commandment of a successful Civil War reenactment: GOALS. This is an easy one as the group wants to improve and expand in order to become the premier event based on its authenticity, its educational value, and its overall promotion of this incredibly important part of our history. There are many reenactments held annually, but perhaps the most important fact of this one is that it is all done via volunteers and from a non profit status. All monies generated go toward sponsoring the next year's event, charitable contributions, and helping the overall reenactor cause.





The Las Mariposas Civil War Days is presented by the Las Mariposas Civil War Group (L.M.C.W.G.) and in association with the N.C.W.A. This spectacular AND authentic weekend includes all of the standard fare you love when participating or just observing and MORE. In its 3<sup>rd</sup> year at this location, the attendance has practically doubled each year and as word gets out, the momentum is gaining.

This year, Education Day is April 24<sup>th</sup>, with over 1000 students and 125 or so teachers registered to attend and traveling all the way from Oregon, Colorado, Northern and Southern California, Arizona, and Nevada. Private schools, home schools, charter schools, and public schools are all encouraged to come, and the day is at NO COST to these attendee's. Sponsored by local businesses and the L.M.C.W.G., and presented by the N.C.W.A. and others, this day has proven to be an experience overwhelmingly popular with all parties, for its depth of education, organization, and overall informational value. The Education Day ends with a feast on site for all reenactors and sutlers; in gratitude for helping us start the weekend off on the right foot.

Saturday and Sunday, April 25<sup>th</sup> and 26<sup>th</sup>, contain the main programs this year and are already slated to be bigger and better than before. Since the event has such an incredible venue on the Longs' Mariposa Ranch, the only limit to the reenactors program is their imagination.




#### THE THIRD REGIMENT OF ARTILLERY

By LIEUT. WM. E. BIRKHIMER, ADJUTANT

Part V

In 1827 the stations of the Third were changed to New England coast, headquarters, Ft. Independence, Massachusetts. Existence tranquil, duties merely routine. The early thirties, however, brought more excitement. In 1831, B, E, H. took station at Fortress Monroe, whence, next year, B and H were sent to Charleston, S. C., to put down the nullificationists; proceeding thence to the disturbed Seminole and Creek Indian districts of Florida and Alabama. When the Florida War broke out C and I were also in the hostile country. This was precipitated by a tragic event familiarly known as Dade's massacre. On December 28, 1835, Brevet Major and Captain Francis L. Dade, 4th Infantry, with one company of the Second and B of the Third, was ambushed near the crossing of the Withlacoochee River, Florida, and all but 4 privates killed, one of whom belonged to B. Captain Upton S. Fraser, 2d Lieut. R. R. Mudge, Brevet 2d Lieut. John L. Keais, and thirty-one enlisted men of the Third fell on the field.

Upon receipt of this intelligence, the steps of the whole regiment were at once bent towards the theatre of hostilities—where A, D, E, F, G arrived in June, 1836. Meanwhile the companies in Florida were actively engaged. On December 31, 1835, C, H were with General Clinch when he defeated the Seminoles near Withlacoochee ford. On March 29, 1836, C, H, I, part of the force under General Clinch, were again engaged near the Withlacoochee. The same companies met the Indians again on June 9 and 19, 1836, the former near Macinope, the latter between that place and Ft. Drane. Later in the year, A, C, H, I encountered the Indians at Ft. Drane, August 21st; on the Withlacoochee River, October 13th; and in the Wahoo swamp, on November 21, 1836. At this time the other companies of the regiment, except B, were in




The Forlorn Hope of Fort King Road by Jackson Walker depicting Dade's battle.

Alabama assisting to overawe the Creeks. B, after its annihilation, was reorganized in Massachusetts, and joined the regiment in the field in January, 1837, being engaged with the enemy at Camp Munroe, Fla, February 8th, following.

During 1837 all the companies were actively employed against the enemy, driving them from one fastness to another, yet rarely seeing them. The service was distressing beyond description. It was almost impossible to bring the Indians to bay except they wished it. Besides, the bullets of a concealed savage foe were less destructive to life than the reptiles abounding and diseases contracted under a vertical sun in the almost boundless and impenetrable swamps. The year 1837 was the season of General Jessup's advent upon the theatre of operations. It was tedious and unprofitable to follow the companies of the Third in all their wanderings through the everglades. Suffice it to say they were constantly on the move, drawing tighter the cordon about the Indians who gradually were being made prisoners or exterminated. All the companies were in the field, traversing the hostile district in every direction. In May, 1837, C was mounted, and with B, 4th Artillery, performed the duty of scouts until the 12th of the following December when the horses were turned in.

The termination of this year was signalized by an event of great interest to the regiment. For the first time since its organization all the companies were united; they were mustered together December 31, 1837, at Fort Christmas, Florida.

The next day the regiment, under Lieut.-Colonel Gates, marched, in Brevet Brigadier Eustis' brigade, against the hostiles, who were defeated, January 24th, at the Locheehatchie. The Indians were now coming in rapidly. But the Cherokees, in the northern part of Georgia, were now to be removed west of the Mississippi, and troops were needed to start them. Accordingly, in April, 1838, A, F, H, I, under Lieut.-Colonel Gates, followed, May 7th, by D, C, E, G, under Brevet Major McClintock, 4th Artillery, and later by B. marched across the peninsula from Fort Jupiter to Tampa Bay, and proceeded via New Orleans and Tuscumbia, Ala., to Chattanooga, Tenn., where the regiment was again, and, so far as known, for the last time united; for, although K was authorized at this time, it was not yet organized. Here the Third remained, camped on the sites of subsequent famous battle-fields, until the Cherokees started west, when it returned, piecemeal, via Augusta, Georgia, to the theatre of active operations in Florida. On November 19, 1838, C was broken up, the men transferred to other companies, and the lieutenants ordered to Carlisle, Pa., where the company, as will hereafter be narrated, was being reorganized as horseartillery. To keep up the equilibrium in Florida, however, K, the newly authorized company, joined December 24, 1838.
